Ordinance

Concerning Annual Appropriation  
Be it ordained by the Board of Trustees of the Town  
of Breckinridge  
That there be and hereby is appropriated  
Dollars, That there be and hereby is appropriated

For the purpose of defraying the necessary expenses of the town of Providence in the County of Providence and State of Rhode Island during the fiscal year beginning on the first day of April A.D. 1900 and ending on the 31<sup>st</sup> day of March A.D. 1901 the following amounts to wit:

For Salary account	\$1800.00
For Street Lighting	" 1700.00
For Fire Department	" 400.00
For Water Works	" 1000.00
Incidental Expenses	" 450.00
Trusts, Alloys and Bridges	" 500.00

Section 2. Provided should there be in any fund more than is necessary or is required for the purposes of such fund the surplus may, by an order of the Board of Trustees, be returned upon the records of their meetings, to be devoted to such purposes or purposes as may to said Board of Trustees seem best.
