

An Ordinance Concerning Sidewalks

Be it ordained by the Board of Trustees of the Town of
Pueblo

Section one: That a sidewalk to and is hereby ordered to
be constructed on and along the west side of Ridge Street
in the Town of Pueblo, Summit County Colorado in
front of adjoining and abutting upon the East line of
lots numbered one (1) Two (2) Three (3) Four (4) Five (5) Six
(6) Seven (7) Eight (8) Nine (9) Ten (10) Eleven (11) Twelve (12)
Thirteen (13) Fourteen (14) Fifteen (15) and Sixteen (16) in
Block Thirteen (13). Also lots numbered one (1) Two (2)
Three (3) Four (4) Five (5) Six (6) Seven (7) Eight (8) Nine (9)
Ten (10) Eleven (11) Twelve (12) Thirteen (13) Fourteen (14) Fifteen
15 and Sixteen (16) in Block Fourteen (14) and also lots
numbered one (1) Two (2) Three (3) Four (4) Five (5) Six (6) Seven
(7) Eight (8) Nine (9) Ten (10) Eleven (11) Twelve (12) Thirteen (13)
Fourteen (14) Fifteen (15) and Sixteen (16) in Block Fifteen
(15) abutting addition to the Town of Pueblo Colorado.
Also lots numbered one (1) Two (2) Three (3) Four (4) Five (5)
Six (6) Seven (7) Eight (8) Nine (9) Ten (10) Eleven (11) Twelve (12)
Thirteen (13) Fourteen (14) Fifteen (15) Sixteen (16) Seventeen (17)
Eighteen (18) Nineteen (19) Twenty (20) and Twenty one (21)
in Block Three (3) in Park addition to the Town of
Pueblo Colorado.

Section Two: All of said sidewalk provided for
in this Ordinance to be built on Ridge Street between
Washington Avenue and the Goldspan Engineering and
Supply Company's office shall be of uniform
grade from Street to Street, six (6) feet in width and
not less than six (6) inches deep and the sidewalk
provided for in this ordinance shall be constructed
with earth, gravel and sand and not less than
two inches of gravel and one inch of sand for top
dressing and curbed on each side with Cobble
