Section 4

That the Town Clerk and Recorder of the Town of Breckenridge be and he is hereby ordered and directed to prepare a local assessment Roll in book form showing in suitable columns each piece of real estate as heretofore assessed the total amount of the assessment against each said piece of real estate and that he certify to same under the seal of the said Town of Breckenridge Colo
