

AN ORDINANCE
 Assessing the cost of laying the
 Sewer in the First Public Sewer
 District of the Town of Brecken-
 ridge, Colorado, against the Real
 Estate in said district: Determining
 the time and manner of Payment of
 said assessment and finding that the
 said improvements were duly and
 lawfully ordered and constructed.

BE IT ORDAINED by the Board of Trust-
 ees of the Town of Breckenridge, Colorado:

SECTION 1. That the real estate herein-
 after mentioned and described is hereby
 assessed in the amount set opposite
 each said lot or parcel thereof for the
 sewer heretofore constructed in the FIRST
 PUBLIC SEWER DISTRICT of the town
 of Breckenridge, Colorado; that is to say:

 amounts and each thereof, shall be due and
 payable to the Town Clerk and Recorder of
 the Town of Breckenridge, Colorado, at his
 office at any time within thirty (30) days
 from the publication of this ordinance.

SECTION 3. That the Town Clerk and
 Recorder of the Town of Breckenridge be
 and he hereby is ordered and directed to
 prepare a local assessment roll in book form
 showing in suitable columns each lot or par-
 cel of real estate hereinabove assessed, the
 total amount of the assessment against each
 said lot or parcel and that he certify to
 same under the seal of the said town of
 Breckenridge, Colorado.

SECTION 4. That the Board of Trustees
 hereby finds that the said sewer was duly
 laid, and said improvements were duly
 made, pursuant to the order of this Board
 duly entered after notice duly and regular-
 ly and lawfully given as provided by law
 and after presentation to the Board of a pe-
 tition therefor subscribed by the owners of a
 majority of the real estate herein assess-
 ed.

SECTION 5. That all ordinances, reso-
 lutions and orders heretofore passed by
 this Board and relating to or anywise con-
 cerning the First Public Sewer District of
 the Town of Breckenridge, or the improve-
 ments therein, be and the same hereby are
 ratified and affirmed and made a part of this
 ordinance.
