

AN ORDINANCE CONCERNING THE WATER WORKS SYSTEM OF THE TOWN OF BRECKENRIDGE, COUNTY OF SUMMIT, STATE OF COLORADO; CONCERNING THE USE OF WATER FURNISHED BY SAID TOWN THROUGH SAID WATER WORKS SYSTEM; ESTABLISHING RULES AND REGULATIONS THEREFOR; FIXING THE CHARGES TO BE MADE BY SAID TOWN THEREFOR, AND AMENDING SECTIONS 1, 2, 3, 4 and 5 OF THE WATER ORDINANCE OF SAID TOWN ADOPTED DECEMBER 11, 1944.

BE IT ORDAINED by the Mayor and Board of Trustees of the Town of Breckenridge, County of Summit, State of Colorado:

Section 1. That the rates or rentals hereafter to be charged, beginning with the first of November, 1947, by the Town of Breckenridge, County of Summit, State of Colorado, for water supplied or furnished by said Town by and through the Water Works System belonging to said Town, are hereby fixed and established as follows, to-wit:

1. For Court Houses, school houses, hospitals and all public buildings, the sum of ten dollars (\$10.00) per month, each, plus an additional monthly charge or rental for each of the following used or maintained in connection therewith, to-wit: living quarters for janitor or other persons, the same rate as herein provided for private residences.

2. For hotels, rooming houses, pool halls, soda fountains, soft drink parlors, barber shops, (each chair), cafes, taverns, filling or service stations and garages, the sum of five dollars (\$5.00) per month, each, plus an additional monthly charge or rental for each of the following used or maintained in connection therewith, to-wit:

- (a) Kitchen - seventy-five cents (75¢).
- (b) Bath, toilet, wash-bowls, sinks, or basins - seventy-five cents (75¢) each.
- (c) Rooms in rear or above thereof used for residences or living quarters, the same rate as herein provided for private residences.
- (d) Hot water systems connected with stove or otherwise - fifty cents (50¢).

3. For lodge rooms or halls, drug stores, offices, grocery stores, meat markets, doctors', physicians' and dentists' offices, or other places of business of a similar nature, the sum of four dollars (\$4.00) per month, each, plus an additional monthly charge or rental for each of the following used or maintained in connection therewith, to-wit:


- (a) Kitchen - seventy-five cents (75¢).
- (b) Private rooms in rear or above thereof, used for residences or living quarters, the same rate as herein provided for private residences.
- (c) Toilets, baths, wash-bowls, and sinks - fifty cents (50¢) each.
- (d) Hot water systems connected with stove or otherwise - fifty cents (50¢) each.

4. For private dwellings, three dollars and fifty cents (\$3.50) per month each, plus an additional monthly charge or rental for each of the following used or maintained in connection therewith, to-wit:

(a) Bath, toilet, lavatory and hot water systems connected with stove or otherwise - twenty-five cents (25¢) each.


5. For persons obtaining water from outside hydrants, whether upon the premises occupied by them or otherwise, or from premises occupied by other persons - two dollars and fifty cents (\$2.50) per month for each such person, if living alone, and for each additional person living with him or her, the additional sum of fifty cents (50¢) per month, the total however, not to exceed the sum of three dollars and fifty cents (\$3.50) per month.

Passed and adopted at an adjourned regular meeting of the Mayor and Board of Trustees of the Town of Breckenridge, County of Summit, State of Colorado, held in the Town Council chambers in said town on the 8th day of October, A. D. 1947, there being a quorum present.
