

PEOPLE'S ORDINANCE NO. 17

SERIES 1984

AN ORDINANCE ADOPTING THE OFFICIAL TOWN
CODE FOR THE TOWN OF BRECKENRIDGE,
COLORADO

WHEREAS, Section 5.12 of the Breckenridge Home Rule Charter directs the Council to codify Town ordinances; and

WHEREAS, all general ordinances of the Town of Breckenridge have been compiled for codification into the Breckenridge Town Code.

NOW, THEREFORE, BE IT ORDAINED BY THE Town Council of the Town of Breckenridge, Colorado:

SECTION I.

The Town Code of the Town of Breckenridge, Colorado, prepared by Sterling Codifiers, Inc., containing the compilation of all ordinances of a general nature together with amendments to said ordinances is hereby adopted as the Official Town Code of the Town of Breckenridge, Colorado, shall hereafter constitute the Official Town Code for the Town of Breckenridge, Colorado and shall be known and cited as the "Breckenridge Town Code."

SECTION II.

Section 1-5-2: Corporate Limits: is hereby repealed.

SECTION III.

The Breckenridge Town Code as herein adopted together with amendments thereto shall hereafter be received without further proof in all courts and administrative tribunals as the official compilation of all ordinances of general and permanent effect.

SECTION IV.

The Town Clerk shall certify to the passage of this ordinance and shall maintain no less than three (3) copies in the office of the Town Clerk, certified as to correctness and available for inspection by the public during regular business hours.

SECTION V.

There is hereby adopted, as a method of perpetual codification, the loose-leaf type of binding together with the continuous supplement service, provided by Sterling Codifiers, Inc., whereby each newly adopted ordinance of a general and permanent nature amending, altering, adding or deleting provisions of the Official Town Code is identified by the proper catchline and is inserted in the proper place in each of the official copies. Each such new provision shall become a part of the Official Code by insertion of the proper replacement pages in the copies of the Code, three (3) copies of which shall be maintained in the office of the Town Clerk, certified as to correctness and available for inspection by the public during regular business hours.

SECTION VI.

All ordinances of a general nature included in this Official Town Code shall be considered as a continuation of said ordinance provision and the fact that some provisions have been deliberately eliminated by the government body shall not serve to cause any interruption in the continuous effectiveness of ordinances included in said Official Town Code. All ordinances of a special nature,

including, but not limited to, matters such as tax levy ordinances, bond ordinances, franchises, vacating ordinances and annexation ordinances shall continue in full force and effect unless specifically repealed or amended by a provision of the Town Code. Such ordinances are not intended to be included in the Official Town Code.

SECTION VII.

It shall be unlawful for any person, firm or corporation to change or amend by additions or deletions, any part or portion of the Breckenridge Town Code or to insert or delete pages or portions thereof, or to alter or tamper with the Breckenridge Town Code in any manner whatsoever which will cause the law of the Town to be misrepresented thereby.


SECTION VIII.

Any person who shall be convicted of a violation of this Ordinance of the Breckenridge Town Code, of any ordinance of the Town, of any code adopted by reference, or of any regulation adopted pursuant to this Code or Town ordinance, shall be fined in an amount not to exceed three hundred dollars (\$300.00) or imprisoned for a term not to exceed ninety (90) days, or both, for each offense; provided; however, that no person under the age of eighteen (18) years as of the date of the offense for which he/she is convicted, shall be subject to a jail sentence, except in the case of a conviction of a traffic offense or as otherwise provided by the Colorado Children's Code.

INTRODUCED, READ ON FIRST READING, APPROVED AND ORDERED PUBLISHED IN FULL ONLY this 14th day of August, 1984. A Public Hearing shall be held at the regular meeting of the Town Council of the Town of Breckenridge, Colorado on the 28th day of August, 1984 at 7:30 p.m. or as soon thereafter as possible in the Municipal Building of the Town.




