AN ORDINANCE AMENDING SECTION 5-4-2 OF THE <u>BRECKENRIDGE</u> <u>TOWN</u>

<u>CODE</u> CONCERNING THE DESIGNATED EMERGENCY RESPONSE AUTHORITY

FOR HAZARDOUS SUBSTANCE INCIDENTS

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF BRECKENRIDGE, COLORADO:

<u>Section 1</u>. Section 5-4-2 of the <u>Breckenridge Town Code</u> is hereby amended so as to read in its entirety as follows:

5-4-2: EMERGENCY RESPONSE AUTHORITY DESIGNATED: Pursuant to section 29-22-102(3), C.R.S., the Police Department of the Town is designated as the emergency response authority for hazardous substance incidents occurring within the corporate limits of the Town. The Police Chief, or the Chief's designee, shall become familiar with the obligations of the designated emergency response authority under any intergovernmental agreement related to hazardous substance incidents to which the Town is a party, and such person shall further meet with an hazardous materials response team identified in such intergovernmental agreement so as to foster good working relationships and communication between the parties.

<u>Section 2</u>. Except as specifically amended hereby, the <u>Breckenridge Town</u> <u>Code</u>, and the various secondary codes adopted by reference therein, shall continue in full force and effect.

<u>Section 3</u>. The Town Council hereby finds, determines and declares that this Ordinance is necessary and proper to provide for the safety, preserve the health, promote the prosperity, and improve the order, comfort and convenience of the Town of Breckenridge and the inhabitants thereof.

<u>Section 4</u>. The Town Council hereby finds, determines and declares that it has the power to adopt this Ordinance pursuant to the authority granted to home rule municipalities by Article XX of the Colorado Constitution and the powers contained in the <u>Breckenridge Town Charter</u>.

<u>Section 5</u>. This Ordinance shall be published and become effective as provided by Section 5.9 of the <u>Breckenridge Town Charter</u>.

A Public Hearing shall be held at the regular meeting of the Town Council of the Town of Breckenridge, Colorado on the 28th day of August, 2001, at 7:30 P.M., or as soon thereafter as possible in the Municipal Building of the Town.
