AN ORDINANCE AMENDING SECTION 9-10-6-1 OF THE <u>BRECKENRIDGE TOWN CODE</u> CONCERNING THE REQUIREMENT TO PAY AN EROSION CONTROL FEE IN CONNECTION WITH THE SUBDIVISION OF REAL PROPERTY

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF BRECKENRIDGE, COLORADO:

Section 1. Section 9-10-6-1 of the <u>Breckenridge Town Code</u> is hereby amended so as to read in its entirety as follows:

9-10-6-1: EROSION CONTROL FEE:

At the time of issuance of a building permit the permitee of a development permit under chapter 1 of this shall pay an erosion control fee in the amount established from time to time by resolution of the town council. Upon the first to occur of the filing of a subdivision plat or the execution of a subdivision improvement agreement pursuant to section 9-2-3-6 of this code, the permitee of a subdivision permit under chapter 2 of this title shall pay an erosion control fee in the amount established from time to time by resolution of the town council.

<u>Section 2</u>. Except as specifically amended hereby, the <u>Breckenridge Town Code</u>, and the various secondary codes adopted by reference therein, shall continue in full force and effect.

Section 3. The Town Council hereby finds, determines and declares that this Ordinance is necessary and proper to provide for the safety, preserve the health, promote the prosperity, and improve the order, comfort and convenience of the Town of Breckenridge and the inhabitants thereof.

<u>Section 4</u>. The Town Council hereby finds, determines and declares that it has the power to adopt this Ordinance pursuant to the authority granted to home rule municipalities by Article XX of the Colorado Constitution and the powers contained in the <u>Breckenridge Town Charter</u>.

Section 5. This Ordinance shall be published and become effective as provided by Section 5.9 of the $\underline{\text{Breckenridge}}$ $\underline{\text{Town}}$ $\underline{\text{Charter}}$.

INTRODUCED, READ ON FIRST READING, APPROVED AND ORDERED PUBLISHED IN FULL this 24th day of September, 2002. A Public Hearing shall be held at the regular meeting of the Town Council of the Town of Breckenridge, Colorado on the 8th day of October, 2002, at 7:30 P.M., or as soon thereafter as possible in the Municipal Building of the Town.
