

ORDINANCE NO. 38

AN ORDINANCE AMENDING CHAPTER 3 OF TITLE 11 OF THE BRECKENRIDGE TOWN CODE, CONCERNING GOLF CLUB REGULATIONS, TO EXEMPT FROM SUCH REGULATIONS CERTAIN NORDIC SKIING AND SLEIGH RIDE ACTIVITIES AND OPERATIONS OCCURRING AT THE BRECKENRIDGE GOLF CLUB

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF BRECKENRIDGE, COLORADO:

Section 1. There is hereby added to Chapter 3 of Title 11 of the Breckenridge Town Code a new Section 11-3-9, to be entitled "Exemption For Nordic Skiing Operations", which shall read in its entirety as follows:

11-3-9: EXEMPTION FOR NORDIC SKIING OPERATIONS: The provisions of this Chapter shall not apply to Nordic skiing or sleigh ride operations or activities which are conducted by the Town at the Breckenridge Golf Club, or which are conducted at the Breckenridge Golf Club with the prior approval and agreement of the Town.

Section 2. Except as specifically amended hereby, the Breckenridge Town Code, and the various secondary codes adopted by reference therein, shall continue in full force and effect.

Section 3. The Town Council hereby finds, determines and declares that this Ordinance is necessary and proper to provide for the safety, preserve the health, promote the prosperity, and improve the order, comfort and convenience of the Town of Breckenridge and the inhabitants thereof.

Section 4. The Town Council hereby finds, determines and declares that it has the power to adopt this Ordinance pursuant to the authority granted to home rule municipalities by Article XX of the Colorado Constitution and the powers contained in the Breckenridge Town Charter.

Section 5. This Ordinance shall be published and become effective as provided by Section 5.9 of the Breckenridge Town Charter.

INTRODUCED, READ ON FIRST READING, APPROVED AND ORDERED PUBLISHED IN FULL this 22nd day of October, 2002. A Public Hearing shall be held at the regular meeting of the Town Council of the Town of Breckenridge, Colorado on the 12th day of November, 2002, at 7:30 P.M., or as soon thereafter as possible in the Municipal Building of the Town.
