AN ORDINANCE AMENDING SECTION 9-1-18-2 OF THE <u>BRECKENRIDGE TOWN CODE</u>, KNOWN AS THE "BRECKENRIDGE DEVELOPMENT CODE", AND SECTION 9-2-3-1 OF THE <u>BRECKENRIDGE TOWN CODE</u>, KNOWN AS THE "BRECKENRIDGE SUBDIVISION STANDARDS", CONCERNING THE SUBMISSION OF APPLICATIONS FOR DEVELOPMENT PERMITS

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF BRECKENRIDGE, COLORADO:

<u>Section 1</u>. The introductory portion of Paragraph (D)(1) of Section 9-1-18-2 of the <u>Breckenridge Town Code</u> is hereby amended so as to read in its entirety as follows:

- 1. General: Complete final application shall consist of the following materials and plans, all of which shall be submitted no later than the deadline established in the Rules and Regulations:
- <u>Section 2</u>. Paragraph (D)(3)(a) of Section 9-2-3-1 of the <u>Breckenridge Town Code</u> is hereby amended so as to read in its entirety as follows:
 - a. Application: Not later than the deadline established in the Rules and Regulations the subdivider shall submit an application and all materials required for planning commission review as provided in subsection D2 of this section.
- <u>Section 3</u>. Except as specifically amended hereby, the <u>Breckenridge Town Code</u>, and the various secondary codes adopted by reference therein, shall continue in full force and effect.
- <u>Section 4</u>. The Town Council hereby finds, determines and declares that this Ordinance is necessary and proper to provide for the safety, preserve the health, promote the prosperity, and improve the order, comfort and convenience of the Town of Breckenridge and the inhabitants thereof.
- <u>Section 5</u>. The Town Council hereby finds, determines and declares that it has the power to adopt this Ordinance pursuant to the authority granted to home rule municipalities by Article XX of the Colorado Constitution and the powers contained in the <u>Breckenridge Town Charter</u>.

<u>Section 6</u>. This Ordinance shall be published and become effective as provided by Section 5.9 of the <u>Breckenridge Town Charter</u>.

INTRODUCED, READ ON FIRST READING, APPROVED AND ORDERED PUBLISHED IN FULL this 13th day of January, 2004. A Public Hearing shall be held at the regular meeting of the Town Council of the Town of Breckenridge, Colorado on the 27th day of January, 2004, at 7:30 P.M., or as soon thereafter as possible in the Municipal Building of the Town.
