# AN ORDINANCE REPEALING AND READOPTING WITH CHANGES APPENDIX "A" TO CHAPTER 2 OF TITLE 9 OF THE <u>BRECKENRIDGE TOWN</u> <u>CODE</u>, KNOWN AS THE "BRECKENRIDGE SUBDIVISION STANDARDS", CONCERNING REQUIRED SUBDIVISION PLAT CERTIFICATES

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF BRECKENRIDGE, COLORADO:

<u>Section 1</u>. Appendix "A" to Chapter 2 of Title 9 of the <u>Breckenridge Town Code</u>, known as the "Breckenridge Subdivision Standards", is hereby repealed and readopted with changes so as to read in its entirety as follows:

## **PLAT CERTIFICATES**

Any substantive variation from the text of the certificates as shown must be approved by the Town Attorney. Any other certificates or notices that are deemed necessary for the purposes of the particular plat shall also be included at the time of its submission. Note: The following plat notes must be customized to fit the facts of the particular plat (i.e., if the owner is not an entity, but are two individuals, the reference to the type of the business entity must be deleted; "has laid out" must be changed to "have laid out"; and so forth.)

<u>Section 2</u>. Except as specifically amended hereby, the <u>Breckenridge</u> <u>Town</u> <u>Code</u>, and the various secondary codes adopted by reference therein, shall continue in full force and effect.

Section 3. The Town Council hereby finds, determines and declares that it has the power to adopt this ordinance pursuant to: (i) the Local Government Land Use Control Enabling Act, Article 20 of Title 29, C.R.S.; (ii) Part 3 of Article 23 of Title 31, C.R.S. (concerning municipal zoning powers); (iii) Section 31-15-103, C.R.S. (concerning municipal police powers); (iv) Section 31-15-401, C.R.S.(concerning municipal police powers); (v) the authority granted to home rule municipalities by Article XX of the Colorado Constitution; and (vi) the powers contained in the Breckenridge Town Charter.

<u>Section 4</u>. The Town Council hereby finds, determines and declares that it has the power to adopt this ordinance pursuant to the authority granted to home rule municipalities by Article XX of the Colorado Constitution and the powers contained in the <u>Breckenridge Town</u> <u>Charter</u>.

<u>Section 5.</u> This ordinance shall be published and become effective as provided by Section 5.9 of the <u>Breckenridge Town Charter</u>.
