

ORDINANCE NO. 5

AN ORDINANCE DESIGNATING THE SUMMIT FIRE AUTHORITY AS THE EMERGENCY RESPONSE AUTHORITY FOR THE TOWN OF BRECKENRIDGE

WHEREAS, Section 29-22-102(3)(a), C.R.S., requires every town to designate by ordinance or resolution an emergency response authority for hazardous substance incidents occurring within the corporate limits of such town; and

WHEREAS, the Town Council finds and determines that the Summit Fire Authority should be designated as the emergency response authority for hazardous substance incidents occurring within the corporate limits of the Town of Breckenridge.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF BRECKENRIDGE, COLORADO:

Section 1. Section 5-4-2 of the Breckenridge Town Code is hereby amended so as to read in its entirety as follows:

5-4-2: EMERGENCY RESPONSE AUTHORITY DESIGNATED: Pursuant to section 29-22-102(3)(a), C.R.S., the Summit Fire Authority is designated as the emergency response authority for hazardous substance incidents occurring within the corporate limits of the Town.

Section 2. Except as specifically amended hereby, the Breckenridge Town Code, and the various secondary codes adopted by reference therein, shall continue in full force and effect.


Section . The Town Council hereby finds, determines, and declares that it has the power to adopt this ordinance pursuant to Section 29-22-102(3)(a), C.R.S., and the powers possessed by home rule municipalities in Colorado.

Section 5. This ordinance shall be published and become effective as provided by Section 5.9 of the Breckenridge Town Charter.

INTRODUCED, READ ON FIRST READING, APPROVED AND ORDERED PUBLISHED IN FULL this 13th day of December, 2011. A Public Hearing shall be held at the regular meeting of the Town Council of the Town of Breckenridge, Colorado on the 10th day of January, 2012, at 7:30 P.M., or as soon thereafter as possible in the Municipal Building of the Town.


This Ordinance was published in full on the Town of Breckenridge website on December 15, December 16, December 17, December 18, and December 19, 2011.

A public hearing on this ordinance was held on January 10, 2012.


