AN ORDINANCE CONCERNING TERM LIMITS FOR MEMBERS OF THE TOWN OF BRECKENRIDGE LIQUOR AND MARIJUANA LICENSING AUTHORITY

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF BRECKENRIDGE, COLORADO:

Section 1. Effective January 31, 2018 Chapter 5 of Title 2 of the <u>Breckenridge Town Code</u>, concerning the Town of Breckenridge Liquor and Marijuana Licensing Authority, is amended by the addition of the following new Section 2-5-4-1, which shall read as follows:

2-5-4-1: TERM LIMITS:

- A. In order to allow for more direct citizen participation in Town government, no member of the authority shall serve more than two (2) consecutive four-year terms in office, and no member of the authority shall be reappointed to the authority if he or she has already completed two (2) consecutive four-year terms in office. Time served on the authority resulting from an appointment made by the Town Council to fill a vacancy on the authority does not count in determining compliance with the limitation of this Section A.
- B. The members of the authority who are in office on January 31, 2018 shall be subject to Section A when their current terms of office expire. No member of the authority may be reappointed if such action would violate Section A. Section A shall not be applied to shorten the term of any member of the authority.
- C. A person who is term-limited under Section A may not be appointed to the authority until four (4) years have expired following the end of term of office that resulted in the person being term-limited.
- D. A person who is term-limited under Section A may be appointed to fill a vacancy and serve out the remainder of the term of office of a member of the commission even though four (4) years have not expired following the end of term of office that resulted in the person being term-limited.
- <u>Section 2.</u> Except as specifically amended hereby, the <u>Breckenridge Town Code</u>, and the various secondary codes adopted by reference therein, shall continue in full force and effect.
- Section 3. The Town Council hereby finds, determines and declares that it has the power to adopt this ordinance pursuant to the authority granted to home rule municipalities by Article XX of the Colorado Constitution and the powers contained in the Breckenridge Town Charter.
- <u>Section 4.</u> This ordinance shall be published as provided by Section 5.9 of the Breckenridge Town Charter, and shall become effective January 31, 2018.
