AN ORDINANCE AMENDING CHAPTER 7 OF TITLE 1 OF THE BRECKENRIDGE TOWN CODE CONCERNING OATHS

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF BRECKENRIDGE, COLORADO:

Section 1. Chapter 7 of Title 1 of the Breckenridge Town Code is amended by the addition of the following sections:

1-7-4: OATHS:

A. When a person is required by Section 4.9 of the Breckenridge Town Charter to take an oath or affirmation before the person enters upon the duties of those public offices and positions described in Section 4.9 of the Breckenridge Town Charter, the form of the oath or affirmation is as follows:

I, (STATE YOUR NAME), do [SELECT SWEAR OR AFFIRM] that I will support the Constitution of the United States, the Constitution of the State of Colorado, the laws of the State of Colorado, and the Charter and ordinances of the Town of Breckenridge, and that I will faithfully perform the duties of [NAME OF OFFICE OR POSITION] upon which I am about to enter to the best of my ability.

B. The oath or affirance must be:

1. In writing and signed by the person taking the oath or affirmation;
2. Administered as provided in Section 1-7-5 of this Code; and
3. Taken, signed, administered, and filed with the Town Clerk or other appropriate Town officer or employee before the person enters upon the public office or position.

1-7-5: WHO MAY ADMINISTER OATHS OR AFFIRMATIONS: The Town Clerk, the Deputy Town Clerk, and the Municipal Judge have the power to administer oaths and affirmations required by Section 4.9 of the Breckenridge Town Charter.

Section 2. Except as specifically amended hereby, the Breckenridge Town Code, and the various secondary codes adopted by reference therein, shall continue in full force and effect.

Section 3. The Town Council hereby finds, determines and declares that it has the power to adopt this ordinance pursuant to the authority granted to home rule municipalities by Article XX of the Colorado Constitution and the powers contained in the Breckenridge Town Charter.

Section 4. This ordinance shall be published and become effective as provided by Section 5.9 of the Breckenridge Town Charter.



A public hearing on this ordinance was held on September 25, 2018.






