AN ORDINANCE AMENDING CHAPTER 1 OF TITLE 8 OF THE <u>BRECKENRIDGE TOWN</u>

<u>CODE</u> CONCERNING THE BUILDING CODES OF THE TOWN OF BRECKENRIDGE BY

ADOPTING BY REFERENCE THE <u>NATIONAL</u> <u>ELECTRICAL</u> <u>CODE</u>, 2020 EDITION

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF BRECKENRIDGE, COLORADO:

<u>Section 1.</u> Item H in the list of codes adopted by reference in Section 8-1-3 of the <u>Breckenridge Town Code</u> is amended as follows:

H. National Electrical Code, 2020 Edition, published by the National Fire Protection Association.

Section 2. Section 8-1-11 of the <u>Breckenridge Town Code</u> is amended to read as follows:

8-1-11: AMENDMENTS TO THE NATIONAL ELECTRICAL CODE: There are no amendments to the <u>National Electrical Code</u>, 2020 edition.

<u>Section 3.</u> Except as specifically amended hereby, the <u>Breckenridge Town Code</u>, and the various secondary codes adopted by reference therein, shall continue in full force and effect.

<u>Section 4.</u> The Town Council finds, determines, and declares that it has the power to adopt this ordinance pursuant to: (i) Section 31-15-601, C.R.S.; (ii) Section 5.13 of the Breckenridge Town Charter; and (iii) the powers granted to home rule municipalities by Article XX of the Colorado Constitution.

<u>Section 5.</u> This ordinance shall be published and become effective as provided by Section 5.9 of the Breckenridge Town Charter.
