(THE KINGDOM OF BRECKENRIDGE)

In Extraordinary Session assembled on the eleventh day of January, 1964; being a Resolution constituting and appointing the City of Voss, Norway, the Sister City.

WHEREAS, The City of Breckenridge, Colorado, also known as and frequently identified as and with the "Kingdom of Breckenridge", has been, is now, and will always be, representative of the finest efforts, traditions, and character of mankind in the "New World"; and

MEREAS, The said City of Breckenridge is steeped in the exciting and glorious history of the Bocky Mountain West and especially the historical quest and finding of the precious metals of gold and silver and the mining thereof; and

WHEREAS, The said City of Breckenridge has been blessed by the Almighty with mountain and alpine beauty unrivaled on the North American Continent which has made it become one of the most outstanding year round resort and recreation areas, being at nine thousand, six hundred and three (9,603) feet in elevation, the highest incorporated city in the world having a ski area; and

MEREAS, The said City of Breckenridge has maintained herself as a repository of friendliness and brotherly love, and through this quality has had the good fortune of being the new adopted home of Trygve Berge and Sigurd Rockne, two of the world's most famous skiers, born in Voss, Norway; and

WHEREAS, The said Trygve Berge and Sigurd Rockne have been instrumental in bringing other outstanding Norwegians to the City of Breckenridge from Voss and other cities, among them the famous jazz pionist, Inge Goddal (Eric Laurence), all of whom have carried on in the finest traditions of their native land to enhance, promote, enlarge, and contribute to the continued and rising position of the City of Breckenridge among world resort and recreation areas; and

MEREAS, The City of Voss, Norway, is to the Continent of Europe what the City of Breckenridge is to North America, being not only steeped in friendliness and hospitality but also one of the most outstanding winter sports areas in Europe and of unparalelled natural beauty;

MOM, THEREFORE, BE IT RESOLVED by the unanimous vote and action of Mayor and City Council of the City of Breckenridge, in extraordinary session assembled, that the City of Voss, Norway be, and by this Resolution is, duly made, constituted, and appointed SISTER CITY OF THE CITY OF BRECKERRIDGE, this said appointment to be effective immediately upon the acceptance of same by the responsible authority of the City Government of Voss; and

BE IT FURTHER RESOLVED, That all friendliness and warmest hospitality be at all times demonstrated to the City of Voss and its citizens now and forever more, and that the sisterhood of Breckenridge and Voss be in every way appropriately commemorated at all appropriate times by the City of Breckenridge and its citizens.

RESOLUTION

The following resolution was introduced and after discussion unanimously approved by the Mayor and the Board of Trustees of the Town of Breckenridge, Colorado, at a "Regular" "Special" meeting of the Mayor and Board of Trustees held at the Town Hall in Breckenridge, Summit County, Colorado, on the

"Be it resolved that the Mayor and Town Clerk of the Town of Breckenridge, Colorado, are hereby authorized to withdraw money now on deposit in savings and loan associations to the credit of the Breckenridge Policeman's Pension Fund and the Breckenridge Fire Department Pension Fund, in such amounts as they may determine and deposit said amounts in the General Fund of the Town of Breckenridge, and upon so doing to make and execute a warrant of the Town of Breckenridge drawn on the General Fund in an amount equal to the amount deposited from funds of either the Police Pension Fund or the Fire Pension Fund. The warrants of the Town made to the Pension Fund shall be duly registered by the Town Clerk and draw interest according to law. The said warrants shall be called for payment when determined by subsequent resolution of the Board of Trustees."
