A RESOLUTION SETTING FEES PURSUANT TO THE COLORADO BEER CODE AND THE COLORADO LIQUOR CODE

WHEREAS, the Colorado legislature recently passed and the Governor signed into law House Bill 97-1076, entitled "An Act Concerning A Recodification of the Laws Regulating the Sale of Beverages Containing Alcohol, and In Connection Therewith Eliminating Obsolete Provisions"; and

WHEREAS, House Bill 97-1076 goes into effect on July 1, 1997; and

WHEREAS, House Bill 97-1076 changed in several respects the fees local licensing authorities may lawfully charge in connection with permits issued and actions taken by such local licensing authority under the Colorado Liquor Code and the Colorado Beer Code; and

WHEREAS, the Town Council of the Town of Breckenridge has determined that the current fees for beer and liquor licenses do not cover the actual and necessary expenses of the Town for processing such applications; and

WHEREAS, the Town Council further finds and determines that the new fees contained in this Resolution are within the limits contained in House Bill 97-1076, and will more closely reimburse the Town for the actual and necessary expenses incurred by the Town in the processing of beer and liquor licenses.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF BRECKENRIDGE, COLORADO, as follows:

Section 1. Effective July 1, 1997, the Town shall charge and collect the following fees pursuant to the Colorado Beer Code (Article 46 of Title 12, C.R.S.) and the Colorado Liquor Code (Article 47 of Title 12, C.R.S.):


Section 2. Effective July 1, 1997, Resolution No. 33, Series 1985, and all amendatory Resolutions thereto, are repealed.
