A RESOLUTION ADOPTING FEES
FOR THE USE OF THE TOWN
COMMUNITY RECREATION CENTER

BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF BRECKENRIDGE, COLORADO, that the following fees for the use of the Town Community Recreation Center are hereby adopted:

**Rental of entire facility is possible only after regular operating hours. Prior arrangement with the Director is necessary.



This Resolution shall become effective upon adoption and shall continue in effect unless or until amended or repealed by subsequent action of the Town Council of the Town of Breckenridge.




